The 2021 Gibson Reorganization meeting was called to order at 6:00 pm

On a motion from Matt Chilcote and seconded by Scott Yandric Matt Chilcot was nominated for Chairman. All present in favor, motion carried.

On a motion from Matt Chilcot and seconded by Scott Yandric, Scott Yandric was nominated for vice-chairman. All present in favor, motion carried.

On a motion from Scott Yandric and seconded by Matt Chilcote, the full-time employees will get a \$1.00 raise, therefore their hourly rate will be \$16. 30.. All present in favor, motion carried.

On a motion from Scott Yandric and seconded by Matt Chilcote the full-time employees will continue to get their health insurance. All present in favor, motion carried.

On a motion from Scott Yandric and seconded by Matt Chilcote all full-time employees will receive 30 hours paid vacation and 16 hours paid sick time, this will be Gaylord, and Dave. All present in favor, motion carried.

On a motion from Matt Chilcote and seconded by Scott Yandric the following holidays will be paid Holidays for the full-time employees Memorial Day, Labor Day, 1 day for Thanksgiving, 1 day for Christmas, Veteran's day and New Years Day. All present in favor, motion carried.

On a motion from Matt Chilcote and seconded by Scott Yandric the Township will continue to match up to 5% of an employee's IRA contributions. All present in favor, motion carried.

On a motion from Matt appointment of Township legal counsel was tabled. All present in favor, motion carried.

On a motion from Matt Chilcote and seconded by Scott Yandric C&N bank will remain the township's bank. All present in favor, motion carried.

On a motion from Matt Chilcote and seconded by Scott Yandric, Scott Yandric was appointed to the Cameron County Tax Collection Committee. All present in favor, motion carried.

On a motion from Matt Chilcote and seconded by Scott Yandric, Brandie Sherry was appointed as the Emergency Management Coordinator. All present in favor, motion carried.

On a motion from Matt Chilcote and seconded by Scott Yandric, Matt Chilcote was appointed to the Solid Waste Bureau. All present in favor, motion carried.

On a motion from Matt Chilcote and seconded by Scott Yandric appointment of the certified public account will be tabled. All present in favor, motion carried.

On a motion from Scott Yandric and seconded by Matt Chilcote, Henry Burrows is appointed to the Chairman of the Vacancy Board. All present in favor, motion carried.

On a motion from Matt Chilcote and seconded by Scott Yandric the mileage rate will be the same as the federal government which is currently 56 cents per mile.
